Program Summary

Purpose of the Scholars Program – To educate and train appropriately prepared GI/endoscopy nurses in order to build a repository of research applicable to the GI/endoscopy setting. Scholars will receive in-person systematic review training utilizing the TCU Center for Evidence-based Practice and Research: A Collaborating Center of the Joanna Briggs Institute.

Scholars Program Dates - January 2016 - December 2018

5-day training class –TBD (like June/July 2016) Meeting and recognition – May 2016 Annual Course

Systematic Review presentation (poster and/or concurrent session) at Annual

Course near or upon completion of review

Criteria for participants include:

- Minimum of 2 years' experience as a GI/endoscopy nurse
- Master's degree (not limited to MSN) or greater
- Current SGNA member
- In good standing with state licensure (unencumbered)
- Active employment at least part-time, either clinically or academically, in a nursing role related to gastroenterology/endoscopy
- Must have access to a healthcare-specific/medical library database in their institutional setting or home community

SGNA will be funding the 5-day training class and associated travel expenses, webinar costs and Joanna Briggs membership costs for the Scholars.
